- The use of acronyms, pseudonyms and slang will be at the discretion of the Election Working Group.

To be eligible for election to the Trust Board you must:

- Fulfil all the criteria as set out in the Trust Rules (<https://www.ycst.org.uk/wp-content/uploads/2017/01/ycst-rules.pdf>) and Board Membership Policy (<https://www.ycst.org.uk/wp-content/uploads/2017/01/ycst-board-membership-policy.pdf>)
- Be aged over 16 years and a member of the Supporters' Trust as at Thursday 9th September 2022
- Be willing and able to attend regular Trust Board meetings (In person and online)
- Be willing and able to contribute constructively and positively to achieve the aims of the Trust and support the business of running York City
- Be nominated by 3 other current Trust members.
